#### **Chairperson's Statement**



#### Research

Over the course of the last seven years, the Institute for Public Policy Research has become part and parcel of Namibia's democratic landscape, as it continues to raise critical policy-related issues for debate and to provide quality research on matters of national importance. During the period under review, the IPPR flagged topics such as the Value Addition Policy, SADC regionalism, Judicial Decision-Making, the BEE landscape and the Structure and Role of the Namibian Parliament.

The network of research associates is slowly expanding, as more and more IPPR publications are produced by up and coming Namibian researchers who work under the guidance of more experienced local and visiting academics and who are given an opportunity to hone their research skills and to find a public platform for their research contributions.

#### **Funding**

We are profoundly grateful to the Ford Foundation and the Finnish Embassy who have provided substantial amounts of direct core funding during the 2006/07 financial year. This has enabled the IPPR to undertake uncommissioned research that falls under its broader institutional objectives and reflects the IPPR's independent research agenda. As reflected in the Audited Income and Expenditures Statement, the 2006/07 financial year ended with a surplus of over N\$188,000, representing an improvement on the previous year and providing some financial leeway. Despite this small success, however, raising long term core funding continues to be an ongoing, major challenge and the IPPR is exploring the full range of possible long term funding opportunities as part of its strategic planning.

#### The future

Clearly, the future of the Institute hinges on its ability to secure at least a minimum of the required core funding from existing and new sources. Furthermore, the IPPR is looking to form strategic alliances with like-minded local and regional bodies to facilitate institutional collaboration, minimize duplication and leverage all available funding opportunities.

#### Conclusion

On behalf of the Board of Trustees, I'd like to thank the Executive Director of the IPPR, Mr. Daniel Motinga, for his unflagging commitment to the work of the organization and his leadership of the staff and research team. Apart from this, our gratitude is due to Mr. Mihe Gaomab II, previous Chairman of the Board, who had to tender his resignation, once he took up a position with a regional research body. His guidance and dedication to the objectives of the IPPR during his tenure were instrumental in building the strength and reputation of the institute. Our best wishes accompany him in his new task. Thanks are also due to my fellow trustees for the important role they have played in managing and overseeing the business of the Institute.

#### **Financials**

The year 2006/07 saw a major reduction in expenditure in line with the restructuring. Total expenditure fell by 51% from N\$2.08 million to N\$ 1.018 million in the year under review. Income saw a small but important upward movement compared to the previous financial year. Total income stood for the financial year ending 28 February 2007 at N\$1.206 million compared to N\$1.136 million during the prior financial year. Grants from the Ford Foundation and the Embassy of Finland accounted for 64% of the total income, thus showing the significance of core funding to the IPPR's operations.

Our accumulated funds at the end of the 2006/07 financial year stood at N\$308.9 thousand compared to an accumulated fund position of N\$157.8 thousand during the previous financial year.

#### Staff and administration

The IPPR has constantly been aware of the need to remain small and flexible over the years. To this end a great deal of freelance researchers and consultants were used to maintain core output on a cost-effective basis. The institute closed the 2006/07 financial-year with two full-time employees and one part-time assistant.

#### Improved visibility

The IPPR continued to maintain its public profile throughout the year, and continues to be a prominently quoted research institute in Namibia. During the review period there was a conscious process of improving our public profile with targeted research output. For example, the paper on Value Addition in Agriculture caused an important debate on the cost and benefits of value addition in the local agriculture. As a result the number of direct citations has increased from a low of 35 during the 2005/06 period to 57 in the current financial year. Our researchers gave commentaries to the media on the restructuring of the Namibia Wildlife Resorts and the MTC Share buy-out as well as the President's State of the Nation Address.
